*Must maintain 3.0 GPA and be in good standing through last regular term.

No Contract Required!

- Enroll in one or more California Community College (CCC) for at least 2 regular terms (excludes summer sessions);
- Last college before UCSD admission is a CCC (excludes summer sessions);
- Complete at least 30 UC transferable units at a CCC.
- Complete the required courses in UC English composition and UC math courses with at least "C" grades by the dates listed above.
- Complete 60 UC transferable units by the dates listed above.
- Earn and maintain a cumulative GPA of 3.0 in all UC-transferable work.
- The UCSD TAG requires full certification of the IGETC general education pattern. *No Partial IGETC is allowed.*

Restrictions of the TAG Agreement:

- The UCSD TAG applies to general admission but not necessarily to a designated **impacted major**. Students must meet the screening criteria for designated majors which require lower-division preparation prior to admission into the major. For additional information about major preparation course work, please refer to see www.assist.org.
- Impacted majors currently include: **Engineering majors within the Jacobs School of Engineering.**
- Effective Fall Quarter 2006, the Jacobs School of Engineering reviews transfer applicants to all impacted and open majors according to completion of engineering major preparation courses.
- If you are a transfer student applying to one of these majors, you must also select an alternate major that is not impacted on your UC application. These decisions will not affect your admission to UCSD, and you could be admitted into either major. You will be notified in writing of the decision after you



- Students must rank the colleges in order of preference on the UC application. *There is no guarantee of college choice.*
- This agreement is available to US Citizens, Permanent Residents, AB540 students, and former UC Students in good standing (not former UCSD students).
- This agreement does not apply to students with senior class standing (students with 90 or more UC-transferable semester units) from accredited four-year universities and community colleges combined.
- Students cannot reach senior standing with only community college units completed. A maximum of 70 UC-transferable community college semester units will be accepted towards graduation. Subject credit is awarded for community college units taken beyond 70 semester unit.
- All UC-transferable units completed at a four-year university apply toward the 90 semester unit limit.
- Advanced Placement and International Baccalaureate units earned prior to high school graduation do not apply to the 90 semester unit limit.
