Pat Newman reviewed the BOT courses. BOT 106, 150 and, 174 were modified to update textbooks and SLO verbiage. BOT 095 is a standalone course and is no longer offered at Cuyamaca. The Administrative Assistant (Associate in Science, Certification of Achievement), Executive Assistant (Associate in Science, Certificate of Achievement), Office Assistant Level I (Certificate of Specialization), Office Professional (Certificate of Specialization) were modified to adjust the level of keyboarding courses, and to show all prerequisite keyboarding courses for transparency. Reviewed and forwarded for action.

ENGL 214: Modification, SLOs

Alicia Munoz reviewed the modifications and SLOs for ENGL 122 and ENGL 214. The course outline for ENGL 122 was modified to update the textbook references and SLOs to become current. ENGL 214 was modified to update the textbook references and SLOs and is currently due for the five-year curriculum review cycle. Reviewed and forwarded for action.

Rob Wojtkowski reviewed the distance learning and emergency remote teaching for ES courses. Rob found that for ES 009ABC, 019ABC, and 028ABC asynchronous teaching modality worked better for students, so they want to offer these courses as distance learning. Julie Kahler brought up ES 014ABC, and 255 require ERT forms if they are to be taught in the spring 2021 semester. Pat Setzer suggested unchecking the "Hybrid Only" box at the bottom of the Distance Learning forms to reduce the need for additional paperwork. Rob Wojtkowski agreed to the edit. Reviewed and forwarded for action.

ESL 2A, 2B: Modification, Distance Learning, SLOs

ESL 2AG, 2BG: Modification, Distance Learning

Guillermo Colls reviewed the modifications and distance learning forms for ESL 2A, 2B, 2AG, and 2BG. ESL 2A and ESL 2AG were modified to lift the prerequisites for both courses. This lifting of prerequisites prevents students from being blocked who wish to take 2A and 2AG together. ESL 2A, 2B, 2AG, and 2BG have been revised to update the textbook references and SLOs to become current. Reviewed and forwarded for action.

HED 120, 201, 203: Review, SLOs

HED 251: Distance Learning, SLOs

Scott Herrin reviewed the HED courses. HED 120, 201, 203, and 251 were modified to update the text and SLOs. HED 251 is being offered up for distance learning due to this course being difficult in ERT format. This course's lab component meets the activity requirement for graduation, so many students take this class to earn credits while progressing through the ESL sequence. A translator was added to the distance learning course to allow it to be easier for ESL students. Reviewed and forwarded for action.

MUS 152, 153, 252, 253, 158, 159, 258, 259: Emergency Remote Teaching

Taylor Smith reviewed the modifications and additions made to the MUS courses. The Music Department wants to add cultural diversity to its course offerings by the addition of MUS 123. MUS 106 was modified to add verbiage in compliance for ADT review as CID previously rejected it. MUS 152, 153, 252, 253, 158, 159, 258, 259 were reviewed for ERT. All courses look good and will be going forward for ERT. Reviewed and forwarded for action.

PSY 138: Modification, SLOs

Marissa Salazar reviewed the modifications made to PSY 138. Marissa informed the committee that she would like to cross-list PSY 138 with SOC 138. Cross-listing this course with SOC will increase enrollment from both PSY and SOC majors and provide students with a unique lens into the intersection of individual and group behavior. SLOs and text for this course have been updated to become current. Reviewed and forwarded for action.

♦ RE 190: Review

RE 125, 292, 294: Deactivations

Pat Newman reviewed the Real Estate courses. RE 190 was modified to update texts and references so that they are current. RE 125, 292, and 294 were submitted for deactivation. These courses have not been offered for nearly ten years. Pat is submitting these courses as deactivations instead of deletions due to the possibility of future reactivation. Reviewed and forwarded for action.

SOC 138: Addition, Assign to Discipline/s, GE (Area D), SLOs

Marissa Salazar reviewed the addition of SOC 138. Marissa informed the committee that social psychology focuses on how others' real or imagined presence impacts individuals' thoughts, feelings, and behaviors, which overlaps with many concepts in sociology. Cross-listing this course with PSY 138 will increase enrollment from both PSY and SOC majors and provide students with a unique lens into the intersection of individual and group behavior. Reviewed and forwarded for action.
