Art and Design (Associates in Arts): Modification
Joshua Eggleton reviewed the modifications made to ART 143 and the Art and Design (Associate in Arts) degree. The outline for ART 143 is being modified to update the textbook and revise the SLO language. The Associates in Arts degree for Art and Design is being modified to reduce the amount of units required to complete a 2-year degree cycle. There were too many units for this degree originally to complete the degree requirements within two years. Reviewed and forwarded for action.

GD 126, 130, 222, 223: Review
Graphic Design (Associate in Science, Certificate of Achievement): Modification
Tom Bugzavich reviewed GD 126, 130, 222, 223, the GD 120 course addition, and the modification made to the Associate in Science degree and Certificate of Achievement for Graphic Design. The text and references have been updated to become current for GD 126, 130, 222, and 223. GD 120 is a new course focusing on UX design which has become a high-growth and in-demand field as the digital world continues to expand. This course is being added as a pathway to four institutions for students. The Associate in Science degree and Certificate of Achievement for Graphic Design is being modified to add the new GD 120 course as an elective. Reviewed and forwarded for action.

- ◆ Dates:
 - The deadline date to turn in curriculum to be approved for the November Governing Board packet is Wednesday, September 22, 2021.
 - The deadline date to turn in curriculum to be approved for the December Governing Board packet is Wednesday, October 20, 2021.
 - The deadline date to turn in deactivations and/or deletions for fall 2022 is Wednesday, November 17, 2021.
- ◆ Articulation Timeline (GE approvals):
 - Courses are submitted for UC transferability once per year in August (the deadline is typically the end of the third week).
 - UC transferability decisions are typically returned no later than October (following submission).
 - Any UC transferability approvals would be effective in the semester we gain approval (courses submitted August 2021 will be effective Fall 2021, if approved).
 - Once we have UC transferability, the course can be submitted for IGETC consideration.
 - Both CSU and IGETC submissions take place once per year in December.
 - CSU and IGETC decisions are typically returned in April and go into effect the following Fall semester (courses submitted in December 2021 will be effective Fall 2022).
 - If approvals come after the college catalog is distributed, information will be published in a catalog addendum.
