Lauren Halsted reviewed the modifications to Anthropology for Transfer. She informed the committee of the shift to the units but noted that the total units was staying the same. Reviewed and forwarded for action.

- ◆ **Art History for Transfer (AA-T):** Modification
Art and Design (Associate in Arts): Modification
ART-Drawing and Painting (Associate in Arts): Modification
Josh Eggleton reviewed the changes being made to ART. He informed the committee of the addition of ART 142 and removal of ART 149 for Art History for Transfer, addition of newer courses being added to Art and Design, and the implementation of both of these changes to ART-Drawing and Painting. Reviewed and forwarded for action.
- ◆ **Chemistry (Associate in Science):** Modification
Robert Anness explained the changes being made to Chemistry. He informed the committee of the renumbering of several Physics courses that required the Chemistry Associates Degree list to be updated. Reviewed and forwarded for action.

Vivi Ricardez-Veasey explained the changes being made to counseling. She informed the committee of the updated, more student-friendly, language to COUN 095 and 120. She also explained the changes being made to the other counseling courses which include textbook and SLO changes. Reviewed and forwarded for action.

Emma Laraby explained the changes being made to CIS. She informed the committee of the catalog clean-up through the removal of old courses that haven't been offered in a while. Reviewed and forwarded for action.

Julie Kahler explained the changes being made to computer science and mechatronics. She informed the committee of the changes to the PHYC courses and the deactivated courses being removed for catalog clean-up. Reviewed and forwarded for action.

Tania Jabour explained the changes being made to ENGL 217. She informed the committee of the plan to revive this course as an online course. The outline was outdated and several overhaul changes were made to adopt this course for a DE setting. Reviewed and forwarded for action.

Civil Engineering (Associate in Science): Modification
Electrical and Computer Engineering (Associate in Science): Modification
Mechanical and Aerospace Engineering Associate in Science): Modification
Keenan Murray explained the changes being made to engineering. He explained the numbering updates to the Physics courses to be aligned with Grossmont College. The lists for the associate degrees are being updated to reflect the changes made to the physics courses. The number of required physics courses for Mechanical and Aerospace Engineering AD are being changed from 3 to 2 in order to help promote the degree. Reviewed and forwarded for action.
- ◆ **ESL 1AS, 1BS, 2S:** Additions, Assign to Discipline/s, Content Review, SLOs
Guillermo Colls explained the additions being made for ESL. He informed the committee that these courses are being changed from companion courses to integrated courses. Guillermo was asked by Jane for the course sequencing of ESL chart to be emailed to her. Reviewed and forwarded for action.

Exercise Science (Associate in Science): Modification
Kinesiology for Transfer (AS-T): Modification
Rob Wojtkowski explained the changes being made to exercise science. He informed the committee of the request from Grossmont to apply a title change to ES 255. Grossmont wants to take a proactive approach to the naming of this course and change it before the universities do. A compromise was found and "recreational" will be added to the title. Rob explained unit changes and updated ES 255 name for the Exercise Science associates degree. The "C" classes are not articulated in the major for the Kinesiology for Transfer degree and are being removed alongside older courses. New classes that are accepted by SDSU will be added instead. Reviewed and forwarded for action.

- ◆ **ETHN 132, 133: Modifications**
Ethnic Studies (Associate in Arts): Modification
Moriah Gonzalez-Meeks explained the changes being made to Ethnic Studies. She informed the committee of the shift being implemented for KUMEY to be the new designator for several courses. This change would include a numbering conflict with BIO 133 therefore the classes were renamed to KUMEY 128 and 129 respectively and will be cross-listed with HIST. Reviewed and forwarded for action.

Vivi Ricardez-Veasey explained the changes being made to the General Studies degrees. She informed the committee of the required updating for clean-up and to include new course additions and deletions. Reviewed and forwarded for action.

GEOG 122: Review, SLOs
Jane Gazale explained the changes being made to Geography. She informed the committee of the GEOG 106 application for the cultural diversity graduation requirement. The cultural diversity is currently being phased out and will be replaced with ethnic studies. Faculty know this is the path forward for the graduation requirement. The committee feels as though this application was strong but not quite strong enough for the cultural diversity graduation requirement but should still be moved forward without it. Jane further explained the SLO updates, textbook updates, and cross-listing of GEOG 122 with GEOL 122. Miriam Simpson or a representative from the department will be invited back to cover GEOG 106. Reviewed and forwarded for action.
- ◆ **GEOL 122: Review, SLOs**
Jane Gazale explained the changes being made to GEOL 122. She informed the committee of the SLO and textbook updates. Reviewed and forwarded for action.
- ◆ **HED: Public Health Science for Transfer (AS-T): Modification**
Jane Gazale explained the changes being made to the Public Health Science degree. She informed the committee of the adjustment of units from 33 to 32 to reflect the BIO 140 unit change. Reviewed and forwarded for action.
- ◆ **History for Transfer (AA-T): Modification, PLOs**
History (Associate in Arts): Modification
Moriah Gonzalez-Meeks explained the changes being made to the History degrees. She informed the committee of changes being made to the numbering and to the alignment of degree maps. The PLOs were updated in the History for Transfer degree. Reviewed and forwarded for action.
- ◆ **HUM 118: Addition, Assign to Discipline/s, GE (Area C), SLOs**
HUM 117: Modification, SLOs
Moriah Gonzalez-Meeks explained the changes being made to the Humanities courses. She informed the committee of the addition of HUM 118 to cross-list with KUMEY 118. There was concern over this course not meeting Area C requirements so changes were made to make the course more explicit and flushed out which include exit skill and SLO updates. Reviewed and forwarded for action.
- ◆ **KUMEY 118: Addition, Assign to Discipline/s, GE (Area C), SLOs**
KUMEY 117: Modification, SLOs
Moriah Gonzalez-Meeks explained the changes being made to the Kumeyaay courses. She informed the committee of the addition of KUMEY 118 to cross-list with HUM 118. These changes parallel the changes for HUM 117 and 118. Reviewed and forwarded for action.
- ◆ **MUS 104: Distance Education**
MUS 161: Review
James Sepulvado explained the changes being made to the Music courses. He informed the committee of the request to make MUS 104 a distance education course as the modality is already complimentary to the layout of the course. He further explained the textbooks for MUS 161. Reviewed and forwarded for action.

- ◆ **OCEA 112:** Review, SLOs
Jane Gazale explained the changes being made to the OCEA 112. She informed the committee of the SLO and textbook updates. Reviewed and forwarded for action.
- ◆ **POSC 166:** Modification
Jane Gazale explained the changes being made to the POSC 166. She informed the committee of the name adjustment to reflect KUMEY as the new designator instead of ETHN in the catalog description. Reviewed and forwarded for action.
- ◆ **STEM 101:** Addition, Assign to Discipline/s, Content Review, SLOs
Jane Gazale explained the addition of STEM 101. The committee discussed this addition and noted that this course would not be degree-applicable and would be linked to COUN 101. This course is geared towards new students and helps promote students success by giving them direct and accurate information. Miriam Simpson or a representative from the department will be invited back to cover STEM 101. Reviewed and forwarded for action.

- ◆ Dates:
 - The curriculum deadline for faculty was March 22, 2023 to meet the May Board packet due date
- ◆ Articulation Timeline (GE approvals):
 - The Articulation Officer determines if courses are CSU transferable.
 - Courses are submitted for UC transferability once per year by August 25th
 - UC transferability decisions are typically returned no later than October (following submission).
 - Any UC transferability approvals would be effective in the semester we gain approval (courses submitted August 2023 will be effective Fall 2023, if approved).
 - Courses that were deemed CSU transferable by the Articulation Officer can be submitted in December of each year to be added to CSU GE.
 - Only Curriculum Committee approval of COR is needed, not Board.
 - Courses that were approved as UC transferable can be submitted in December of each year to be added to IGETC.
 - Only Curriculum Committee approval of COR is needed, not Board.
 - CSU and IGETC decisions are typically returned in April and go into effect the following Fall semester (courses submitted in December 2022 will be effective Fall 2023).
