### PARALEGAL STUDIES 170 – WORKERS' COMPENSATION

1 hour lecture, 1 unit

## **Catalog Description**

Overview of California's Workers' Compensation statutes, including the concept of no-fault insurance and the administration of contested compensation claims for death, disability, and vocational rehabilitation. Students will compute awards based upon current benefit formulae.

# Prerequisite

"C" grade or higher or "Pass" in PARA 100 or equivalent

#### **Entrance Skills**

Without the following skills, competencies and/or knowledge, students entering this course will be highly unable to succeed:

- 1) Have a basic understanding of the legal system.
- 2) Be familiar with basic legal concepts and basic legal language.
- 3) Knowledge of the state and federal court system.
- 4) Understand administrative law and the administrative system.
- 5) This course will deal with a major area of substantive law and how it relates to other areas of the law, so an understanding of substantive and procedural law is critical.

- 5) Apply principles of administrative law to compensation claims.
- 6) Calculate entitlement benefits in compensation claims.
- 7) Understand the role and ethical and professional responsibilities of the paralegal in the Workers' Compensation practice.
