

PROFESSIONAL DEVELOPMENT TEACHING & LEARNING COMMITTEE

Charge

This committee coordinates professional development for all college constituencies and makes decisions on the allocation of professional development funds that support the strategic priorities as outlined in the institutional planning documents. These priorities are intended to advance and improve student success and equity. This committee recommends policy on professional development issues within the framework of Title 5 regulations. This committee will collaborate with the Teaching & Learning Coordinator (formerly PD Coordinator) to develop and plan the criteria, direction, priorities, and policies related to professional learning for faculty, classified, and administrative employees, based on the College's strategic priorities and commitment to racial equity, anti-racism, social justice, and student-centered practices. As part of this work, the committee will help to create and manage the College's Center for Teaching and Learning. The committee will assess professional learning needs and the efficacy of professional development activities. The committee will also collaborate with the College's participatory governance leadership to provide professional development for their members, and with the professional development leads at Grossmont College and the District on district-wide professional development activities. This committee reports to the Student Success and Equity Council (SSEC), and reports matters of faculty development to the Academic Senate and matters of classified development to the Classified Senate.
