- Online Teaching Conference (OTC)
 - The [Online Teaching Conference](#) is scheduled to be in person from Wednesday, June 29 – Friday, July 1st in Long Beach. The pre-conference workshops will be held on Wednesday, June 29th, and the main conference will run Wednesday afternoon until Friday, 7/1. Faculty submitted an interest form, and we are working to coordinate the paperwork and registration.

 - STEM Grant: Terrie Nichols sent an email to the STEM chairs to collect faculty interest, and I sent a follow-up to all STEM faculty. I am asking for faculty to notify me of their interest by **today, March 10th**. Faculty will earn an \$1800 stipend by participating in a 6-week online Humanizing STEM course, facilitated at the state.
