### II. Announcements

A. Academic Senate President Election Results: Lamia Raffo informed the senate that Manuel Mancillas-Gomez won the 2022-2024 Academic Senate President elections. He received 101 votes out of a total of 105 votes. Congratulations to Manuel Mancillas-Gomez!

### III. Information (First readings and updates for future action) –

- A. FACCC: Wendy Brill-Wynkoop informed the senate of the Advocacy Training Events being held in 2022. These meetings will be held on January 18, 2022, February 15, 2022, March 22, 2022, April 26, 2022 and May 24, 2022 from 6pm-8pm. Wendy also informed the senate of the two AB bills that were recently passed, AB 928 and AB 1111. AB 928: Associate Degree for Transfer Intersegmental Implementation Committee was passed which establishes the Associate Degree for Transfer (ADT) Intersegmental Implementation Committee that is charged with oversight of the ADT. This committee will establish a singular lower division general education pathway that meets both CSU and UC academic transferring requirements. This bill will remove the IGETC and CSU Breadth and replace it with one pattern that covers both areas by May 31, 2023. This bill will affect enrollment. AB 1111: Common Course Numbering System was passed which requires the CCC to adopt a common course numbering system for all GE requirement courses and transfer pathway courses by July 01, 2024. This item is for informational purposes only.
- B. Equity in Employment Taskforce PE 2, 9, and 12 Revision Updates: Moriah Gonzalez-Meeks and Taneisha Hellon informed the senate of the revisions that have been made to PE 2, 9, and 12 since the last Academic Senate meeting. Reviewed and forwarded for action.
- C. Facilities Presentation (Link): Francisco Gonzalez informed the senate of all of the upcoming construction projects that will be taking place on the Cuyamaca College campus that will be starting soon. He provided a map with the construction zones marked. This item is for informational purposes only.
