Hi All,

As promised here is your email with updates. I did not include the documents the Tim Corcoran sent out but I will talk about them in this email ;)

On July 13th employees who CANNOT do their work remotely will be required to return to campus, employees who can work remotely but wish to return to campus MAY do so. Those who CAN continue to work remotely and wish to do so are able to. Those who CANNOT work remotely and CANNOT return due to a variety of reasons need to contact HR.

The forms from Tim will need to be completed by July 31. If you have any questions or concerns about these forms let me know and we can discuss them with HR and our Union.

The county of SD has cleared us at this time to return to campus, even though classes will be online this fall.

CSEA has purchased enough masks for every member to receive 1 mask.

The sheriff contract has been reduced, we had 1 sergeant and 4 deputies, we will now have no sergeant and 2 deputies between the campuses from 7am-5pm. Our contract has the flexibility to add if needed.
