Those eligible for consideration to receive scholarship grants shall be enrolled at a California College or University for professions which are centered on, or support a career in real estate transactional activity such as: Real Estate Brokerage, Real Estate Finance, Real Estate Management, Real Estate Development, Real Estate Appraisal, Real Estate Planning, Real Estate Law and other fields of study the Trustees feel worthy of consideration. _____ The applicant must have **completed** a minimum of twelve college level course units within the last four years, at least two of those completed courses must have been Real Estate or Real Estate related studies.

_____ Students must have maintained a cumulative grade point average of 2.6 or higher from all Colleges/Universities attended.

_____ Students must be a legal resident of the State of California for at least one year prior to the date of application and have a valid California Driver's license or California State Identification card. A copy of the license or ID card must be submitted with this application.
