## **Your VA Education MHA**

The Cuyamaca Veterans Center is pleased to announce that the regulation that is safeguarding your Post 9/11 GI Bill housing allowance has been extended to December 21, 2021. The regulation, which can be found **here** states that "GI Bill students will continue to receive housing allowance payments at the resident training until 12/21/2021, or until the school resumes normal operations of resident training, for programs converted solely to online training."

Continuing the protections set forth for the Fall 2020 semester, Cuyamaca College is continuing the school policy for virtual campus by providing a way for you to distinguish which classes will be considered for certification as in-person.

VA Education benefits require that at least one class be certified as in-person in order for a student to receive full MHA benefits.

### On the VA Education Website

#### Regulations of Senate Bill S.3505

As stated below, only classes which have a resident training counterpart may be certified as an in-person class. This means that if a class that has been converted to an online format due to COVID-19 and would otherwise be offered in-person, it can be approved as an in-person class. If a class is offered online but would be offered online regardless of the pandemic, it can only be approved as distance learning.

Special COVID rules extended to December 21, 2021.

We will be updating the content below to convey the extension.

From the beginning of this crisis, we have been working with Congress to preserve GI Bill benefits for those of you impacted by COVID-19 during this difficult time. On March 21st the The President signed into law \$.3503, giving VA temporary authority to continue GI Bill payments uninterrupted during an emergency.

The new law allows VA to pay education benefits regardless of the fact that a program has been converted from
resident training to online training, even if a online training hasn't been or approved or is not approvable.

GI Bill students will continue to receive housing allowance payments at the resident training until 12/21/20, or until the school resumes normal operations of resident training, for programs converted solely to online training.

Q1. My school changed my program from in-residence classes to online classes? Can I still get GI Bill benefits for this?

Based on the recently passed legislation, if your school converts from an approved residence training course to online training for that course (distance learning) due to COVID-19, your benefits will not change. However, the law only authorizes this special authority from March 1, 2020, to December 21, 2020.

The new law applies to both current and new students enrolled in courses affected by COVID-19.

Note: Other types of changes to your enrollment status (for example, dropping a class results in a reduced rate of pursuit) may affect payments.

Q2. What happens to my housing allowance if my school changes from in-residence classes to online classes due to COVID-19?

Post-9/11 GI Bill students whose schools convert to online programs from previously approved resident programs will not see reduced monthly housing payments. Current and new beneficiaries can receive the resident housing rate when in school March 1, 2020, to December 21, 2020.

Note: Other types of changes to your enrollment status (for example, dropping a class results in a reduced rate of pursuit) may affect payments.
